Declaration

I, the undersigned, herewith apply for participation in the Karoo Meat of Origin certification scheme.

- For this purpose I acknowledge that an auditor will visits the listed production units to evaluate its compliance with the standard of reference.*
- To the best of my/our knowledge, all the information supplied in this application is accurate.*
- I have full management control of the production units detailed in this application.*
- I have read and agree to comply with all the Karoo Meat of Origin standards applicable to the production unit.*
- All membership fees are approved at the annual general meeting.*

Terms and Conditions

- The applicant agrees not to challenge, in any manner, the KDF's rights in the certification marks.*
- The Applicant hereby agrees and undertakes to keep the KDF indemnified and to hold the KDF harmless against all loss or damage, from any cause arising, which the KDF may sustain as a result of having granted the Applicant permission to use or apply the certification marks.*
- The Applicant's right to use and apply the certification marks in terms of this agreement is only a user right, strictly in compliance with the KDF's rules of certification and subject to the KDF's supervision and strict control, and the Applicant will not acquire any independent right or ownership or interest in the certification marks as such.*
- The Applicant's right of use contemplated herein will be personal to the Applicant and may not be ceded or transferred to another party without the KDF's permission.*
- The initial term of the proposed right to use the certification marks ends at midnight at the beginning of the fourth anniversary of the date upon which the audit was passed and the KDF accepts this application. A follow up audit can take place any time within the 4 year period. The term of this agreement (consisting of the initial term) will automatically be extended (provided that the follow up audit was passed successfully),*



unless no later than three (3) months before the beginning of any such extension, either party notifies the other in writing that it does not wish to extend the term of this agreement.

- In the event of any substantial breach of the terms of the agreement or the non-compliance with the rules for certification (as hereby included or as amended from time to time), and/or failing an audit, and failure of the Applicant to implement corrective action within a reasonable period of time, the KDF shall have the right to terminate the Applicant's right of use of the certification mark.*
- Upon termination of the agreement between the parties, the Applicant will immediately cease any use of the certification marks and will forthwith return to the KDF any material containing or reflecting the Proprietor's certification marks (for example, the KDF's ink stamps or any subject matter displaying the certification marks), either by courier or registered mail or in person.*
- The KDF does not give any warranties or indemnities to the Applicant, and have not induced the Applicant's participation with any representations whatsoever.*
- An application fee as well as other costs (as per the Minimum Standards document) must be paid for the use of the certification mark(s).*
- The Applicant shall permit the KDF (or appointed third party) to enter the farm or production unit or premises where the certification marks are applied, during business hours, to inspect the meat products and the application of the certification marks, or any aspect of compliance with the rules of certification, and the Applicant shall afford the KDF such facilities or assistance as may be reasonably required to enable the KDF (or appointed third party) to ensure that compliance with the rules of certification is being observed.*
- The Applicant acknowledges that the KDF is entitled to mandate any third party to act on its behalf and to represent the KDF in exercising its rights under this agreement, or performing any of the supervisory tasks, or exercising control, as contemplated by the rules of certification.*
